### 6. ACCIDENTAL RELEASE MEASURES

#### 10. STABILITY AND REACTIVITY

**Stability**: Stable under normal conditions of use. Reacts violently with strong

oxidising agents.

**Conditions to Avoid**: Avoid heat, sparks, open flames and other ignition

sources.

Materials to Avoid Prevent vapour accumulation.

**Hazardous**: Strong oxidising agents.

**Decomposition Products**: Thermal decomposition is highly dependent on conditions.
